PRIVATE PROPERTY TOWING CONTRACT

This contract is between _____ and AFA Towing, for the property located at, _____.
Strap # _____ This contract will be valid for the term of one year as of the date listed above or until either party decides to cancel. By signing below you acknowledge that you are the property owner or the agent for the property owner, and you have the right to make decisions regarding this property. You also agree to conduct yourself in accordance with all Florida statutes, and county ordinances. You have read and have access to a copy of Lee county ordinance 13-19.

All Tows for impound from your property will require a "Tow Sheet" form to be filled out at the time of tow by you or an agent for you that you have listed on page 2. On this "Tow Sheet" **we will have to record that person's name, drivers license number, and personal home address**, as stated in LC 13-19 Section 11, (4) and Section 15, (2). No impound tow will be done without this information and **the "Tow Sheet" may be given to the owner of the vehicle.**

Impounds on other than cars and trucks will be on a case by case basis, and may require additional charges to you, (the property owner) should you decide to have certain vehicles or vessels removed. A price will be given after we see what would need to be removed. The purpose for this is to compensate for the cost of disposal after title or certificate of destruction has been issued to us.

If a person needs to be added or removed from the list of agents for this property, you must submit a new contract with the corrected information.

No "Tow Sheet" or other permissions can be issued prior to the exact date and time of the impound tow being done as per LC 13-19. No rebate or compensation from us to you (the property owner/agent) for this contract or impounds done will be paid.

Tow signs that meet the requirements of FS 715.07 and LC 13-19 and must be prominently placed at each driveway access or curb cut allowing vehicle access to the property, setback five feet from the right-of-way line. If there are no curbs or access barriers, signs must be placed at 25 foot intervals along the property frontage. The signs must be permanently installed not less than four feet, but not more than 6 feet, above ground level and be continuously maintained on the real property for a period of not less than 24 hours prior to the towing or removal of any vehicle. Failure to maintain the appropriate signing is a violation of ordinance 13-19 and we will not be able to tow from that property until it is corrected.

Any person or entity improperly causing a vehicle/vessel to be recovered, towed, removed or stored is liable to the vehicle/vessel owner for the costs of the services provided; any damages resulting from the removal, towing and storage of the vehicle/vessel; and, attorney’s fees and court costs.

Please fill out the following with person(s) you wish to have the rights to meet us at the time of tow to sign “Tow Sheet” and give authorization to us to remove vehicles / vessels.
